**The Plan of Nashville** Dec 25 2022 The Plan of Nashville is a community-based vision of how the urban core of Nashville should look and work in the 21st century. The purpose is to help the central city hold its place in civic life. Since Nashville assumed a metropolitan form of government - merging city and county - there have been almost a hundred plans that dealt with some aspect of the center city. This plan is different. The Plan was conceived and orchestrated by the Nashville Civic Design Center, which is committed to the practice of urban design. This three-dimensional discipline integrates streets and buildings, land use and transportation - a new approach for Nashville. As a private not-for-profit, the center listens with independent ears and speaks with an independent voice. Previous plans by Metro government departments and their consultants were constrained by politics and patronage, by available funding or the need to solve specific problems. Plan of Nashville is not an island bound by the noose of the interstate loop. The Plan integrates downtown with the areas that frame it via the spoke roads that are the historic entries into downtown. Rather than taking a top down approach, the design center organized the process of listening to the community. Over 400 citizens attended a series of workshops in downtown and the surrounding neighborhoods to express their opinions and draw their dreams. The center's staff translated the results into a series of maps and illustrations, with explanatory text - that articulate a three-dimensional vision for the city that will serve as a litmus test for current and future development.

Civic Talk Jan 22 2020 Does talking about civic issues encourage civic participation? In his innovative book, *Civic Talk*, Casey Klofstad shows that our discussions about politics and current events with our friends, colleagues, and relatives—"civic talk"—has the ability to turn thought into action—from voting to volunteering in civic organizations. Klofstad's path breaking research is the first to find evidence of a causal relationship between the casual chatting and civic participation. He employs survey information and focus groups consisting of randomly assigned college freshman roommates to show this behavior in action. Klofstad also illustrates how civic talk varies under different circumstances and how the effects can last years into the future. In describing the life and times of the man, the authors provide a fascinating analysis of the developments in British architecture and planning from the 1930s to the 1970s. The book explains the story of a wartime policies for post-war reconstruction and examines policies which have had a major influence on the shaping of modern towns and cities. Holford's involvement in planning in the post-war period shows how gradually the concept of 'civic design' has been discarded to the detriment of the urban landscape. His position in the thick of development conflicts, such as that of Piccadilly, have much to tell us about the workings of developers and planning authorities, and the failings of the planning system in the pressures for growth in the 1960s. In this key period of British architectural and planning history, Holford was a leading actor, and describing his role the book provides a very readable account of a little explored area.
