From Kaiserreich to Third Reich Nov 27 2022 Originally published in English in 1986, this book offers a concise summary of the contribution Fritz Fischer and his school made to German historiography in the 20th century and in particular draws attention to continuity in the development and power structures of the German Reich between 1871 and 1945. After 1866 the traditional elites wanted to avoid fundamental changes in society, expecting a victorious war to secure their own position at home and to broaden the European base of the German Reich. Even as the Blitzkrieg expectations foundered, these ambitions persisted beyond 1918. In the face of working-class hostility, these elites were unable to mobilize mass support for their interests, but Hitler fashioned a mass party. The alliance between these unequal partners led to the Third Reich but with its collapse in 1945 the Prusso-German Reich came to an end. Only with the German Federal Republic did the liberal-democratic traditions of German history again come into their own.

Germans, Jews, and Antisemites Mar 27 2020 The ferocity of the Nazi attack upon the Jews took many by surprise. Volkov argues that a new look at both the nature of antisemitism and at the complexity of modern Jewish life in Germany is required in order to provide an explanation. While antisemitism had a number of functions in pre-Nazi German society, it most particularly served as a cultural code, a sign of belonging to a particular political and cultural milieu. Surprisingly, it only had a limited effect on the lives of the Jews themselves. By the end of the nineteenth century, their integration was well advanced. Many of them enjoyed prosperity, prestige, and the pleasures of metropolitan life. This book stresses the dialectical nature of assimilation, the lead of the Jews in the processes of modernization, and, finally, their continuous efforts to 'invent' a modern Judaism that would fit their new social and cultural position.

Rethinking the World Aug 13 2021 Stunning shifts in the worldviews of states mark the modern history of international affairs: how do societies think about—and rethink—international order and security? This finely-focused study of the exchanges between individual politicians and diplomats, whether domestically or across the Rhine, also examines the relationship between the official sphere, the press, and a range of cultural associations and initiatives. It also explores the role of key economic associations and pressure groups whose energies were harnessed by Paris and Berlin in the cause of rapprochement. These were complex processes where success or failure could rest on particular personal exchanges, a badly-timed election, or unanticipated economic upsets that compromised

diplomacy's best-laid plans.

Forced to change by necessity, those involved in state-sponsored conservation institutionalized and professionalized their efforts, while several private groups became more confrontational in their message and tactics. Through their steady and often conservative presence within the mainstream of West German society, conservationists ensured that by 1970 the map of the country was dotted with hundreds of reserves, dozens of nature parks, and one national park. In doing so, they assured themselves a strong position to participate in, rather than be excluded from, the left-leaning environmental movement of the 1970s.
